## **CONDITIONAL PLEA OFFER**

The defendant is charged with the following in the above case:

LEWD OR LASCIVIOUS BATTERY (2 COUNTS)

I am making the following plea offer:

The Defendant will enter a plea of no contest to CHILD ABUSE (2 COUNTS).

Two years community control followed by one year probation with the following special conditions:

- a. No contact directly or indirectly with victim C.S.
- b. If victim C.S. initiates contact with defendant, defendant is not to respond in any manner.
- c. Remain at least 500 feet from victim C.S., her residence, place of work, and school at all times.
- d. Warrantless search and seizure by probation officer of the defendant's residence, car, phone, and computer.
- e. Provide probation officer with immediate and full access to telephone and internet communications including but not limited to: call logs, text logs and messages, instant messaging logs and messages, emails, social media accounts, Skype or similar accounts, and account names, numbers and passwords for all such accounts.
- f. Psycho-sexual evaluation + successful completion of any recommended treatment
- g. 150 hours community service to be completed at a minimum 10 hours per month
- h. No early termination of community control or probation

Both counts to run concurrent

The State will defer to the Court as to adjudication.

The above proposal is based upon the State's present understanding of the defendant's criminal history. Should our initial assessment prove incorrect this offer is subject to revocation.

On February 15, 2013, at approximately 2005 hours, I conducted a controlled phone call between and Kaitlyn. The following is a summary of that call.

While speaking with , Kaitlyn told her that she has had other people talk to her (speaking about being in a relationship with them), but she loves . told Kaitlyn that she was her anything to Kaitlyn. Kaitlyn said that obviously it meant something to her.
